Frequently Asked Questions

Q: When I make a gift, is there anything additional required to be recognized in Unparalleled Partners?

A: Yes. We ask all donors to confirm their recognition naming preferences, consent to a Statement of Shared Values and designate family members as applicable.

Q: How do I qualify for facilitated access?

A: Your cumulative giving commitment to Houston Methodist (since 2003) must total \$100K to receive 24-Hour Facilitated Access at the Champion giving level.

Q: Can my qualifying gift be made as a pledge?

A: Yes, outright gifts and pledge commitments of \$50K+ qualify (pledges may not exceed five years).

Q: Will my additional family members continue to receive recognition after my passing?

A: All recognition will remain in place for the lifetime of the Primary Donor(s).
